**Conditions for Participating in Events**

**Release and Assumption of Risk**

1. I am aware that while I participate in events at Treble Cone Ski Area certain risks and dangers exist and that there is a possibility of an accident, illness, serious injury or death resulting from such activities. I understand that such risks cannot be eliminated without jeopardising the central qualities of skiing, snowboarding and other activities. I also understand that Treble Cone Investments Limited (Treble Cone) and its employees, directors, officers, agents and associates cannot provide one on one supervision and monitoring all of the time and for all of the activities.
2. In consideration of, and as part payment for the right to participate in such events and/or all other activities and services conducted in Treble Cone Ski Area I hereby assume all of the above risks and hold Treble Cone and its officers, directors, employees, agents and associates harmless from any responsibility, negligence, actions or suits of any kind or nature whatsoever for loss or damage to any property (including my own) or personal injuries sustained or occurring during any racing or other activities and events conducted at Treble Cone Ski Area.
3. The release referred to in paragraph 2 above also applies to any loss or damage suffered during travel or while in accommodation.
4. Should Treble Cone, or anyone acting on its behalf, be required to incur legal fees and costs to enforce this release and assumption of risk, I agree to indemnify them for all such fees and costs.
5. These terms shall serve as a release and assumption of risk for me, my heirs, executors and administrators and for all members of my family, including any minors accompanying me.
6. By signing this release and assumption of risk, I acknowledge that if anyone is hurt or property is damaged during my participation in any activities at Treble Cone Ski Area, I have waived my right to sue Treble Cone and its respective employees, agents, officers, directors and associates.
7. Nothing in this release and assumption of risk by me is intended to have the effect of contracting out of the provisions of the Consumer Guarantees Act 1993, except to the extent permitted by that Act, and all provisions of this release and assumption of risk by me shall be read as modified to the extent necessary to give effect to that intention.
8. Where the participant is under 18 years of age, I am the parent or guardian of the participant and warrant that I have the authority to enter into this release and assumption of risk on behalf of the participant and myself.
