MAJOR EVENTS

FIS World Championships 2009

- (a) Selection Process:
 - (i) Nominations are to be sent to SRNZ (attn. General Manager) no later than November 15, 2008
 - (ii) A subcommittee of the SRNZ High Performance committee will be selected to evaluate/rank athletes. The selection committee will be comprised of:
 - A. SRNZ General Manager (Non-voting Chairperson)
 - B. SRNZ National Team Coach(es)
 - C. SRNZ NDT Coach
 - D. Winter Performance Program Representative
 - E. Regional Representative
- (b) The selection committee will render a recommendation to the SRNZ Board based on a thorough review of the athlete's past performances relative to the selection criteria and the athlete's potential to perform at the required level for the World Championships.
- (c) Selection Criteria:
 - (i) An athlete who meets NST "A" Status Criteria or
 - (ii) An athlete who has scored World Cup points on one or more occasions between November 2007 and December 2008
- (d) Discretionary Selection Criteria:
 - (i) Consideration will be given to athletes who meet NST "B" Status criteria and have clearly shown potential to represent New Zealand with distinction at the World Championships.
- (e) Meeting the criteria does not guarantee selection. It does guarantee that the selection committee will perform a thorough review of the athlete's past performances. An important consideration will be the quality of competition where the athlete achieved his/her results. Greater consideration will be given to



higher level competitions with widely representative international fields and depth in the quality (world rankings) of the field;

- (f) The valid FIS list at the time of entry deadline for the World Championships will be used for selection.

FIS World Junior Championships 2009

- (g) Selection Process:

- (i) Nominations are to be sent to SRNZ (attn. General Manager) no later than November 15, 2008

- (ii) A subcommittee of the SRNZ High Performance committee will be selected to evaluate/rank athletes. The selection committee will be comprised of:

- A. SRNZ General Manager (Non-voting Chairperson)
 - B. SRNZ National Team Coach(es)
 - C. SRNZ NDT Coach
 - D. Winter Performance Program Representative
 - E. Regional Representative

- (h) The selection committee will render a recommendation to the SRNZ Board based on a thorough review of the athlete's past performances relative to the selection criteria and the athlete's potential to perform at the required level for the World Junior Championships.

- (i) Selection Criteria:

- (i) Athletes who meet NST "B" or "C" Status and age criteria

- (j) Discretionary Selection Criteria:

- (i) Consideration will be given to athletes who meet NDT criteria and have clearly shown potential to represent New Zealand with distinction at the World Junior Championships.

- (k) Meeting the selection criteria does not guarantee selection. It does guarantee that the selection committee will consider the athlete's nomination.

- (l) The valid FIS list at the time of entry deadline for the World Junior Championships will be used for selection.

- (m) Should the number of athletes qualifying exceed the number of quota spots available, the team will be selected on the basis of the athlete's GS World Junior Rank plus his/her World Junior Rank in their next best discipline.
